Dear Fellow Conservationist:

The Maryland Association of Soil Conservation Districts (MASCD) is pleased to provide you with this registration package for the 2009 National Association of Conservation Districts Northeast (NACD NE) Regional meeting. We have the date – we have the location – and we have plans for a fun-filled, educational event here in America in Miniature – Maryland.

The next NACD NE regional meeting will be held at the Holiday Inn in Solomons, Maryland on July 26-29, 2009, registration materials are included with this package. We have a room block reserved at the Holiday Inn at Solomons, in Calvert County, Maryland, room costs are \$97.00 for a single and \$107.00 for a double room plus 6% state and 5% Calvert County tax; the cutoff date is June 26, 2009, but I recommend that you book early as there are only limited options available close by. Reservations canceled 24 hours prior to arrival for a full refund.

We will showcase some of the activities in the Chesapeake Bay watershed and have invited Maryland Governor Martin O'Malley to share details of the state's efforts with you at the Opening Session.

On Monday night we will be holding a Banquet and Live Auction. Maryland's soil conservation districts will be donating items to auction for the MASCD Environmental Education Endowment Fund and we invite you to donate items to raise funds for the NACD National Conservation Foundation. **Activities of Special Interest:**

- **USDA NRCS National Listening Session**—NACD NE is hosting a USDA National Listening Session on the Resource Conservation Act. Invitations will be sent to a broad range of agencies and interest groups. States should come prepared to sign up and make comments. - **Green Infrastructure Training**—NACD, in cooperation with Natural Resources Conservation Service is hosting a special 5-hour workshop on Green Infrastructure. The instructors come from The Conservation Fund, a national leader in this training. The workshop will draw from the publication, *Green Infrastructure: Linking Landscapes and Communities* by Dr. Mark A. Benedict and Edward T. McMahon. Conservation districts across the nation are working to help individuals and communities protect and properly use the natural resources in developed and developing areas. This workshop is designed to give conservation districts another tool in their work. To keep it an interactive learning opportunity, the session is limited to 25 participants. ## TOUR INFORMATION

**Sunday, July 26, 2009, 1:00-5:30**

**NACDE Tour of Washington, DC and the Smithsonian's Soil Exhibit "Dig It – The Secrets of Soil"**—The tour starts at 1:00 p.m. from the main entrance of the Holiday Inn returning at 5:30 p.m. Relax in the comfort of an air-conditioned coach and take a ride through scenic Maryland to our Nation's Capital. Explore the fascinating world of soil and other unique exhibits at the Smithsonian Museum of Natural History in Washington, D.C., <http://forces.si.edu/soils>. A fun and educational trip for you and your family. Bottled water will be provided on the tour. Please eat lunch before boarding the bus at the hotel. The cost of the trip is \$35.00; use the registration form to sign up and pay for the tour.

**Tuesday, July 28, 2009, 8:30-12:00**

**Auxiliary/Spouse Tour – Sotterley Plantation**—Experience part of America's history over 300 years in the making. Located on the banks of the Patuxent River, this 1703 Tidewater Plantation features an architecturally significant Mansion of unique post-in-ground construction with beautiful woodwork including a Chinese Chippendale staircase. A National Historic Landmark, Sotterley has been home to generations of prominent families including that of the sixth Governor of Maryland, and later, the daughter of financier J. P. Morgan. The 90 acre site includes Colonial Revival gardens with panoramic views of the river, a rare original Slave Cabin, a smokehouse, a necessary, a Customs Warehouse and nature trails. Sotterley has a Museum Shop also. (website: [www.sotterley.org](http://www.sotterley.org)). A continental breakfast will be served at the Plantation on the Portico to enjoy Sotterley's magnificent vistas. Sotterley is just 9.5 miles away and transportation will be arranged (probably by car-pooling). *Costs for participation in this Tour is included in the Spouse's Registration fee, but you must sign up as a headcount is needed.*

**Tuesday, July 28, 2009, 12:45-4:00 p.m.**

**Tour A – Shoreline Management and Boat Tour of Solomons Island**—Captain Glenn James will steer the good ship "The Bounty Hunter" from the dock at the Holiday Inn into the picturesque Patuxent River. This is Maryland's largest river with the watershed boundary within the state. On the tour you will see low impact shoreline protection installed in the harbor, off-shore breakwaters and embankment stabilization practices for high impact shoreline protection and learn about Maryland's efforts to clean up the Patuxent River—as well as enjoy an afternoon "just messing about on the river". This tour departs Holiday Inn dock at 12:45 p.m. Enjoy your box lunch onboard The Bounty Hunter, but sign up early as the maximum cargo is 45, first-come, first-served.

**Tour B – Agri-tourism**—Forrest Hall Farm and Orchard, this tour departs from the front of the Holiday Inn at 12:45 p.m. and returns at 4:00 p.m. Maximum 49. Participants will get to enjoy their box lunch at the Forrest Hall Farm and Orchard picnic pavilion. Forrest Hall Farm and Orchard owners Joe and Mary Wood will present a history of their farm and the process that they went through to convert to an Agri-tourism and Alternative Agriculture operation. Participants can get lost in their corn maze, visit the farm shop, and see their greenhouse and wine grape operation. At the end of their presentation you will have an opportunity to ask questions as well as shop for some fresh fruits and vegetables.

**Tour C – Innovations in Conservation**—New technology is likely to provide the key for improved crop yields, better utilization of nutrients and improved nutrition. Innovations in urban conservation design are changing the way development exists with the natural environment. This tour will explore innovative equipment, practices and designs, including an opportunity to see a demonstration of the new GreenSeeker™ imaging equipment and poultry litter injection equipment (negotiations underway). Both of these tools have the potential to greatly improve nutrient efficiency. This tour will leave the front of the hotel at 12:45 p.m. and return at 4:00 p.m. Maximum 49.

- Directions to Hotel:
  - From the north: follow I-95 south towards Baltimore and take the Harbor Tunnel towards Annapolis. Keep right and take I-895 spur towards I-97 south towards Annapolis/Bay Bridge. Take the MD-2 South Exit towards Glen Burnie. Merge onto I-97 south for 9 miles. Take the MD-32W/MD3 south exit, Exit 7 towards Bowie/Odenton. Merge onto Crain Highway for 19 miles. Merge onto MD-4 towards Prince Frederick for 42 miles. Follow this road south for 42 miles to Solomons and turn left onto Solomons Island Road South and right onto Holiday Drive.
  - From the west: from the Washington beltway (I-495), take Exit 11A MD-4 towards Pennsylvania Avenue/Upper Marlboro, Merge onto MD-4 south for 50 miles and turn left onto Solomons Island Road South and right onto Holiday Drive.

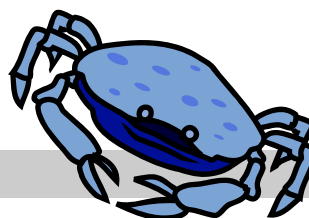
