MARYLAND SOIL CONSERVATION HISTORY (1)

Organized efforts to control soil erosion in Maryland started in 1935 and have continued to the present. Several histories that cover various aspects of these activities have been prepared. The Maryland Soil Conservation Leaders Association has assembled these histories in this publication.

Mr. Fred Bull, former Executive Secretary of the State Soil Conservation Committee recorded some of the history of the Maryland Association of Soil Conservation Districts in 1969. Information was organized around the first six presidents of MASCD, 1945-1969. MASCD published this under the title "History of Maryland Association of Soil Conservation Districts, Inc." Some of that publication is included in this publication. (2)

The history of soil conservation activities centering around MASCD Presidents was continued by Arnold Hawkins, Executive Secretary of the State Soil Conservation Committee, 1967—1983. Information relating to the SSCC was included because the President of MASCD was a member of the SSCC. Information regarding activities during each president's term of office, up through the term of Donald L. Spickler, July, 1987, is included here under the title "MASCD Presidents and Soil & Water Conservation." The Association has recommended that each president develop a history of their administration. (3)

An appendix to the history, "MASCD Presidents and Soil & Water Conservation" was also started by Arnold Hawkins. It included information on bylaws, awards, etc. Space was provided to record future award winners. (4)

"Soil & Water Conservation In Maryland, 1935—1985" was assembled by Arnold Hawkins for the observance of the 50th Anniversary of the Soil Conservation Service. It includes information on activities prior to the formation of SCS, the Civilian Conservation Corps (CCC) Camps, the soil conservation districts formed in Maryland, the Maryland SCD Law, the State Soil Conservation Committee, etc. This publication has an appendix, which includes an article, "The Beginnings of SCS" by Harold Scholl, former State Resource Conservationist for SCS in Maryland. (5)

A sincere thank you to Maryland Association of Soil Conservation Districts and the MASCD Auxiliary for the purchase and distribution of this history and to Barbara Butler, Secretary in the Allegany Soil Conservation District, for assistance in typing and arranging for the printing of this history.

A thank you also to the Allegany County Board of Education, and the Allegany County Vocational Technical Center for the printing and binding of this history.
